Coverage Summary

The standard limited warranty covers 12 months or 2,000 total hours of operation and applies to all refrigeration product units.

COVERAGE

Volta Air's Limited Warranties are provided by Volta Air Technology Inc. ("Volta Air") and cover defects in workmanship and materials.

WARRANTY PERIOD

These warranties last for a Warranty Period that varies by product from the date of purchase at point of sale to you, the original end user customer. The standard limited warranty covers 12 months or 2,000 total hours of operation and applies to all A/C or reefer product units. The extended warranty and service plan is also offered at additional charges and may expand coverage to 36 months. We offer single or multiple year plans to best suit your budget. VOLTA AIR WILL

Volta Air will, at its option, repair or replace the defective product free of charge, provided that you notify Volta Air of the product defect within the Warranty Period for your product, and provided that Volta Air through inspection establishes the existence of such a defect and that it is covered by the Limited Warranty.

Volta Air will, at its option, use new and/or reconditioned parts in performing warranty repair and building replacement products.

Volta Air reserves the right to use parts or products of original or improved design in the repair or replacement. If Volta Air repairs or replaces a product, its warranty continues for the remaining portion of the original Warranty Period or 90 days from the date of the return shipment to the customer, whichever is greater. All replaced products and all parts removed from repaired products become the property of Volta Air.

Volta Air covers both parts and labor necessary to repair the product and return shipment to the customer via a Volta Air - selected non-expedited surface freight within the contiguous United States and Canada. Alaska and Hawaii are excluded. Contact Volta Air customer service for details on freight policy for return shipments outside of the contiguous United States and Canada.

International customers are responsible for paying freight charges (both inbound & return) for in-warranty replacement or repair.

OBTAINING SERVICE

If your product requires troubleshooting or warranty service, contact your merchant. If you are unable to contact your merchant, or the merchant is unable to provide service, contact Volta Air directly at the number listed on the website in the support section for your product.

In any warranty claim, dated proof of purchase must accompany the product and the product must not have been disassembled or modified without prior written authorization by Volta Air.

Proof of purchase may be in any one of the following forms:

- The dated purchase receipt from the original purchase of the product at point of sale to the end user, or
- The dated dealer invoice or purchase receipt showing original equipment manufacturer (OEM) status, or
- The dated invoice or purchase receipt showing the product exchanged under warranty

WARRANTY DOES NOT COVER

Volta Air Limited Warranties do not cover normal wear and tear of the product or costs related to the removal, installation, or troubleshooting of the customer's electrical systems. These warranties do not apply to and Volta Air will not be responsible for any defect in or damage to:

- a) the product if it has been misused, neglected, improperly installed, physically damaged or altered, either internally or externally, or damaged from improper use or use in an unsuitable environment;
- b) the product if it has been subjected to fire, water, generalized corrosion, biological infestations, or input voltage that creates operating conditions beyond the maximum or minimum limits listed in the Volta Air product specifications including high input voltage from generators and lightning strikes;
- c) the product if repairs have been done to it other than by Volta Air or its authorized service centers (hereafter "ASCs") or without consulting Volta Air;
- d) the product if it is used as a component part of a product expressly warranted by another manufacturer;
- e) the product if its original identification (trade-mark, serial number) markings have been defaced, altered, or removed.

LIABILITY:

Volta Air is liability free in the contract, under Personal Injury Law, or Tort including strict liability or negligence. Volta Air shall have also no liability in case of any accident of vehicles, product cargo, injuries including economic and non-economic injuries, contents, intellectual property, incidental, lost profits, loss of use, and interruption of business. Volta Air will only be liable and cover the part and labor.

The express Warranty of Volta Air does not cover any material or product which is not made by Volta Air. For example brackets that are used for mounting Volta Air engine-driven compressors, tensioners, pulleys, belts and installation hardware. Volta Air has no responsibility for the installation process, including the installation material and products which are not made by Volta Air. e.g. bracket kit components, bracket design, or workmanship.

EXCLUSIONS

If your product is a consumer product, federal law does not allow an exclusion of implied warranties. To the extent you are entitled to implied warranties under federal law, to the extent permitted by applicable law they are limited to the duration of this Limited Warranty.
